S/2606/19/TP, 1 The Pines – Crown lift Lime or Linden to 3-4m above selected stems; Fine;
S/2633/19/TC, 40 Pierce Lane – Remove Leylandii; No comment, may be down already;
S/2634/19/TP, 6 & 8 Wilbraham Road – 2 x Horse Chestnuts, crown lift one and clear phone line with second; no objections;
S/2720/19/TP, 8A Cow Lane – Sycamore, Crown thin and reduce spread. No objection;
S/2727/19/TP, 74 Cow Lane – Sycamore – remove to ground level and plant another; fine;
S/2745/19/TC, 18 Home End – Elder and Sweet Bay. Remove; consent already granted;
S/2809/19/TC, Remove overgrown hedgerow between 40a and 42 Pierce Lane; Fulbourn Parish Council feels this is a desecration of the greenery and have been contacted by several concerned residents.
S/2810/19/TC, Chestnut House, Sanders Lane – Fell Chestnut. FPC feels it unnecessary to fell this Chestnut and would be happier with a crown reduction (this application has now been withdrawn); also S/2808/19/TC, crown reduce Hawthorn by 1 to 1½m. No objection;
S/2814/19/TC, 2 Balsham Road – Mauve Prunus, reduce lateral branches by 2-3 m. No objection;
Cow Lane – Remove Walnut Tree phased over 2 years then replace with suitable specimen;
S/3015/19/TC, 33 Apthorpe Street – Fell Apple Tree as close to house which has planning permission for a rear extension; No objection.
