BUSES: service changes

The Combined Authority's bus procurement concluded last month, with all eighteen routes which had been cut by Stagecoach, seeing some level of service reinstated. The Nos. 11 and 12 are now being run by Stephenson's of Essex, as noted in colleagues' reports.

The Combined Authority had set aside £1.7M for subsidies to operators to keep them running. Currently, the total cost is expected to be about £1.25M because bus operators were limited in what services they were prepared to provide. The Combined Authority will be monitoring how the new services are working.

As well as ensuring vital bus services continue between October and the end of March 2023, the Combined Authority is working to put in place a sustainable and affordable bus network from April 2023 onwards.

All this is a sharp reminder of the reality of the current deregulated bus system, and the problems caused by sixty per cent of bidding authorities in England, including Cambridgeshire & Peterborough, receiving no Government funding for their Bus Service Improvement Plans (BSIPs).

The Combined Authority's Overview & Scrutiny Committee was told in a report from its lead member for buses that two reasons had been given for the failure of the Department for Transport to fund Cambridgeshire's Bus Service Improvement Plan:

1. in DfT's view we had insufficient commitment to road charging, active travel and bus priority schemes in our area; and

2. the DfT subsequently applied a deprivation index score to each BSIP submitted and given our high overall growth, this meant that the money tended to be allocated in the north of England rather than to us.

A refreshed Bus Strategy for Cambridgeshire and Peterborough is due to be presented to the Combined Authority's Transport & Infrastructure Committee in November, alongside a refreshed Bus Service Improvement Plan and a case for Government investment.

Work is also continuing to further develop the business case for a franchised bus network in Cambridgeshire and Peterborough, but this will need money for the necessary investment in the service.

BUSES: Mayoral precept

The Mayor of Cambridgeshire & Peterborough meets regularly and informally with leaders of the member councils of the Combined Authority, including the County Council. One idea he raised in one such meeting was whether there might be a case for setting a Mayoral precept to be added to the Council Tax, to fund bus services beyond March 2023.Cambridgeshire County Council and Peterborough City Council would both have a veto over such a proposal.

A bus network covering more than just a few key urban routes will need public subsidy, and the money for this will need to come from somewhere—either central government, or local government.

The Government has already refused to fund Cambridgeshire's Bus Service Improvement Plan once. Will we be more fortunate this time? The Chancellor of the Exchequer is also known to be looking for billions of pounds in spending cuts. How likely are we to see the kind of Government investment we need? There are some questions for us all here: locally, some politicians have opposed the Greater Cambridge Partnership congestion charge proposals, and also opposed the idea of a Mayoral precept. If we continue to receive no money from central government, and if all sources of local government funding for improved buses are opposed, how else will the necessary investment in bus services be raised to move Cambridgeshire to a more sustainable franchised model of bus transport?

Greater Cambridge Partnership

The Greater Cambridge Partnership has now opened its public consultation on its proposals for a significant expansion of bus services in Cambridge (for the phased launch of which from 2023 funding is available) and the city's travel to work area, to be paid for, in due course after 3 years, by the introduction of a congestion charge in Cambridge in 2027/28.

It is important to read the full package of proposals (a better bus services for our area, along with better walking and cycling connectivity, a sustainable travel zone with a congestions charge) complete the survey, and let the Greater Cambridge **Partnership know what the proposals would mean for communities as well as for individuals. It is a consultation.**

Booklets setting out the whole package of proposals, along with the survey form, have been sent to thousands of households. Information is also available on line and there are many online and in

person webinars and exhibition venues with chance to ask questions and offer views and raise concerns. The survey closes at midday on Friday 23 December. 

This is proposed to be spent once again on school meal vouchers for the school holidays, and on direct one-off grants to eligible households. It is proposed that such grants should be raised from ± 100 to ± 110 to reflect increasing inflation.

Interim Tree & Woodland Strategy



The interim strategy will serve while the Council gathers information about what trees the Council has, where they are, and how the Council can improve and expand its tree assets. Once the Council has this baseline information it can start to plan for the future.



Fens Reservoir

Anglian Water and Cambridge Water have now announced their preferred location for a new Fens reservoir north of Chatteris.

The timeline for such a big project is a long one, with multiple consultations, an application to the Secretary of State, construction expected to start in 2029-31 and the reservoir to open in 2039-41. The indicative timeline is as follows.

20MPH scheme Proposals for the process to award funding for applications for 20MPH schemes will be reported to the December meeting of the Highways & Transport Committee. I have been pressing for this to be put in place as soon as possible. It is likely that the applications window will open in February and close at the end of April. But this is all to be confirmed.

HGV policy The draft HGV policy I reported last month has now been approved with a couple of minor additions about length and width restriction applications.

FIRE AUTHORITY Budget The Chief Fire Officer for Cambridgeshire has warned that there will have to be reductions to the service unless the way in which it is funded changes.

As part of national negotiations a revised cost of living pay award of five per cent was offered for firefighters. Combining this with the offer already on the table for support staff, Cambridgeshire's fire service will be in budget deficit of at least £1.1m at the start of April 2023. CFO Chris Strickland said the service wanted its employees to be given a pay increase that reflected the current

rate of inflation, but also had a responsibility to deliver a balanced budget, and these were currently at odds.

At the moment, fire and rescue services can only ask for a maximum of two per cent increase in council tax, which is around an additional $\pounds 1.50$ per year for Cambridgeshire council taxpayers (based on a Band D property).

The Chair of the Fire Authority, Cllr Edna Murphy, said: "This year's increase in fires, as a result of the prolonged hot, dry weather, has shown us that we will need the fire service more in the future, not less."

Fulbourn Issue

This month it's mainly about gulleys and pipes. Gulleys in most of Fulbourn were cleared in September and October. There were a few places not tackled. These have been picked up by a senior highways officer and will be done soon. Some areas also needed pipes jetting through to source: Home End has been done; Geoffrey Bishop Avenue needs to be done. We are 'onto that'

<u>Other local issues:</u> residents have raised with me the delays to patching of footpaths, following mark-up, as well as missing white lines and signs. These are all on the 'little list' monitored closely by me and our LHO, but it is taking longer to get things done, there is no doubt. We had Brexit and Covid. There are shortages of people and materials and costs have shot up, as we all know, following the mini-budget and other crises. On the subject of white lines, there are 67 jobs in the queue for one firm. Fulbourn has moved up the list.

Support for providing Electric Vehicle Charging Points

A new scheme is being launched this month to help parish councils and operators of community buildings to provide publicly accessible electric vehicle charge points (EVCPs), in order to encourage electric vehicle (EV) uptake within the district.

Parish Councils and those operating community buildings will be able to South Cambridgeshire District Council for grants of up to £5,000. The application form requires applicants to describe and justify the location for the EVCP. There must be a good prospect of current or future demand for the EVCP for the installation to be worthwhile. Demand may be from nearby residents who do not have access to on-street parking, or from nearby amenities such as shops, public houses, rail stations or other attractions where EV users may benefit from being able to charge their vehicle nearby.

The scheme is being funded from the Council's Renewables Fund.

Cost of Living Crisis Funding for Parish Councils

You will know from last month's report that South Cambridgeshire District Council has declared a Cost of Living Crisis. In response to this the Council's Community Chest Grant scheme criteria has been altered to allow Parish and Town Councils of any size to bid for Community Chest grants that provide a benefit to those affected by the cost-of-living crisis.

The criteria has been expanded to allow applications for revenue costs or overheads (for example, salaries, rent, advertising, promotional materials) to be included for all projects that provide a benefit to those affected by the cost-of-living crisis. But it does not include food costs.

A sum of £20,000 in addition to the Community Chest budget has been ring-fenced specifically for this with a limit of £2,000 per bid. A Parish Council can only make one bid in line with existing Community Chest criteria. This £20,000 comes from the Integrated Care System funding, which SCDC is administering, and which must be committed by the end of March 2023, for the purposes of delivering projects that provide a benefit to those affected by the cost-of-living crisis.

Changes to Stagecoach Bus Services update

With the exception of Stow-cum-Quy broadly speaking the villages in our ward of Fen Ditton and Fulbourn were unaffect by the withdrawal of 18 Stagecoach bus routes and one A2B route on 30 October.

As to Stow-cum-Quy, having lost Stagecoach route12 it is now served by an hourly Monday to Saturday service between Newmarket and Cambridge (numbered 11) operated by Stephensons of Essex. Unfortunately passengers for Soham and Ely will now have to change at Cambridge or Newmarket. Stephensons has also registered the former Stagecoach 11 service, which ran along the A1303, as a commercial route, but has numbered it 12! So, residents in Wilbraham can still pick up this bus on the A1303 at Bottisham.

Our other Stagecoach routes which are all commercially operated continue as before (namely, the citi 1 and 3, 16a and 19 and the extension of the Newmarket Road P&R bus to Stetchworth), although there are new timetables on all. There is no timetable change to the A2B operated 18 which runs between Teversham and Newmarket.

The Mayor is only funding the Stephensons route 11 and A2B route 18 until the end of this financial year (that is 31 March 2023). With the lack of Government support for rural buses, he is considering a ring-fenced bus precept on all council taxpayers in Cambridgeshire to ensure there continues to the a fund to subsidise these services.

Greater Cambridge Partnership "Sustainable Travel Zone"

Just a reminder, that the public consultation by GCP for its proposed City Access scheme closing on 23 December 2022.

Key features of the proposed City Access package are:

• New bus routes, additional orbital and express services, and a huge increase in rural coverage, with buses supported by Demand Responsive Transport.

• Longer operating hours from 5am to 1am and more frequent services - 6-8 buses every hour in the city and from market towns, and hourly rural buses.

• Flat fares to make public transport cheap and accessible for all; with passengers paying £1 to travel in the city and £2 in the travel to work area.

• Options for new cross-city cycling routes to encourage more active travel, enhancing Greater Cambridge's reputation as the UK's leading cycling city.

Better buses and reduced bus fares would be phased-in before any Sustainable Travel Zone was introduced. The City Deal can forward-fund the bus upgrades now to build confidence in services to help people make the modal shift from private car to bus, but the changes require longer term funding. Under the proposals, all vehicle movements into, out of and within the STZ would pay a flat daily charge - unless exempt or eligible for a discount or rebate scheme included in the consultation - between 7am and 7pm on weekdays. The revenue generated by the STZ, which would not be introduced until 2027/28, would be ring-fenced for the bus network and transport improvements.

The City Access package is central to the GCP's integrated transport network – providing the thread that links together the GCP's busway and active travel schemes to transform how people travel across the area.

South Cambridgeshire top for hosting Ukraine families

Ukraine families continue to settle into life in South Cambridgeshire thanks to a range of grant-funded activities organised by the District Council including day trips, English classes, free laptops, books and bikes.

Six months since the government launched its Homes For Ukraine scheme, the Council remains the top District in the country for hosting families, with 808 visas issued and 720 guests arrived so far, since the government's scheme began in March 2022.

The council has provided extensive support to families fleeing the war with the help of local partnerships including more than 340 items of free tech goods delivered such as 93 laptops, 77 Chromebooks, 52 mobile phones and 124 SIM cards.

In addition, hundreds of English lessons have been given plus day trips to help people integrate into life in a new country.

Warm Hubs

Warm Hubs have been designed to support vulnerable and isolated people, as well as those on lower incomes; at a time when the cost of living is a significant challenge. In South Cambridgeshire, the first Warm Hubs have opened at Gamlingay and Caldecote. Hardwick, Cottenham and Comberton will be the next villages to see <u>Warm Hubs</u> open their doors. More hubs will open in November across both South Cambs. Operated from community buildings across East and South Cambridgeshire

The new initiative has been developed by South and East Cambridgeshire District Councils and funded by NHS Cambridgeshire & Peterborough, part of our local Integrated Care System.

As an affiliated network, the Warm Hubs are coordinated by Cambridgeshire ACRE – the charity dedicated to supporting and strengthening rural communities across Cambridgeshire.

Operating at the heart of local communities, the Warm Hubs concept has been designed to offer warm, friendly and inclusive places with access to light refreshments. Hubs also provide residents with somewhere to socialise, take part in activities and receive information on how to reduce bills, access financial support, and stay healthy and well.

The activities and services available at Warm Hubs are operated by trained volunteers from within the local area who are individuals who understand the needs of the local communities.

Batteries cause bin lorry fire

Recently there was a fire involving a refuse collection vehicle that was collecting black bin (non-recyclable) waste. The cause of the fire is believed to have been batteries which had been placed inside a black wheelie bin. When batteries are put into a wheelie bin, it is possible for them to split when mixed and compacted with other waste or recycling in the back of the collection lorry – which can cause a fire.

The correct way to dispose of all types of portable household battery (for example, Li-ion, AA, C, D, button, laptop) is to put them inside a small plastic bag and attach that bag to the handle of your blue bin for kerbside collection. There are also collection points in all major retailers that sell batteries. For example, supermarkets and electrical shops.

Head of Greater Cambridge Shared Waste, Bode Esan, said: "We're grateful to Cambridgeshire Fire and Rescue Service and Cambridgeshire Police for their quick response to this fire. I'm pleased that nobody was hurt but this is a reminder about why it is so important batteries aren't put inside wheelie bins. They can cause fires like this in our collection vehicles. Used batteries should instead be put in a clear plastic bag which can be tied to the handle of your blue bin, if disposed of at home instead of battery collection points.

"Even if they don't cause a fire in one of our vehicles, which can put it out of action for some time and disrupt our collections, batteries put inside wheelie bins will end-up in landfill. Once there, they will leak out toxic chemicals which can be harmful to people and wildlife. I'd also encourage residents to consider buying rechargeable batteries as modern ones hold their charge much better than was previously the case and can be charged more quickly."

Greater Cambridge Shared Waste is a partnership between South Cambridgeshire District and Cambridge City Councils. It collects recycling and rubbish from around 127,000 households.

Combined Authority approves £100,000 for community led housing

The Combined Authority has unanimously agreed that a further £100,000 of funding be made available to support community-led housing initiatives across Cambridgeshire and Peterborough.

Community-led housing involves local people playing a leading and lasting role in solving housing problems, creating genuinely affordable homes and strong communities. It can involve building new homes, returning empty homes to use and managing existing homes.

Funding challenges are often met by incorporated community led housing groups in the early stages of a project. Examples include meeting the costs of viability appraisals, addressing legal and planning issues, addressing site specific issues such as ground investigations, entering into arrangements for securing a legal interest in a site, conveyancing and preparation of partnership arrangements.

The approved £100,000 will provide a source of follow-up funding in circumstances where it can be demonstrated that it could address challenges and maintain project momentum.

Speaking of the decision by the board, Mayor of Cambridgeshire and Peterborough, Dr Nik Johnson, said "Community led housing is an essential part of our commitment to providing affordable housing across our districts, and I'm delighted that the board unanimously agreed to this additional funding. By supporting our communities and their desire to build community assets, not only will we increase the overall supply of affordable homes, but we will also see an increase in empowered and engaged communities across Cambridgeshire and Peterborough." I thought it would be worth Parish Councils knowing of this fund in case they decide to get involved with small housing projects / exception sites in the future.
